Memo: Authorization to pay Fine & Costs
without appearing in Court

If you have received a ticket or complaint for any of the offenses listed below, you may enter a written plea of guilty and pay your fine and court costs without personally appearing in court. To do so, you or someone acting on your behalf must present your driver's license, your copy of the traffic ticket/complaint with your signature on the back, payment of the fine and costs to the: Court Clerk at Sikeston Municipal Court, 105 East Center Street, Sikeston, Missouri, 63801, located at City Hall.

- Hours of operation: 8:00 a.m. to 5:00 p.m. Monday through Friday; Phone 573-475-3705; Facsimile 573-471-1526
- No payments for traffic tickets/complaint accepted after 12:00 noon on the DAY of court, no exceptions.
- No written plea of guilty or fines will be accepted if you have more than two prior convictions for the same or a similar offense within 2 (two) years preceding the date of the violation.
- You have the right to a trial if you wish.
- Signing a Plea of Guilty and paying fines and costs will have the same effect as a court judgment.

NOTICE: Failure to appear on the court date indicated on your ticket or to satisfy your ticket in the manner provided above, may result in the issuing of a warrant for your arrest.

ALL FINES AND COURT COSTS ARE TO BE PAID IN FULL UPON ENTRY OF A PLEA OF GUILTY, OR A FINDING OF GUILTY BY THE COURT.
